Explanation of Responses:

The vested RSUs which converted on August 1, 2025 are reported in Table II on this Form 4.
2. Each restricted stock unit is the economic equivalent of one share of Sidus Space, Inc.'s Class A Common Stock.
3. On August 1, 2025, the reporting person was granted 9,167 RSUs, of which 7,206 vested upon the date of grant, 490 vested on October 1, 2025 and 490 vest on each of January 1, 2026, April 1, 2026 and July 1, 2026. The Class A Common Stock into which such vested RSUs converted on August 1, 2025 is reported in Table I on this Form 4.
