#### Item 4. Ownership.

The information required by this item with respect to each Reporting Person is set forth in Rows 5 through 9 and 11 of the cover page to this Schedule 13G and is incorporated herein by reference for each such Reporting Person. The ownership percentages reported are based on (i) 10,662,736 shares of Class A Common Stock outstanding as reported in the Issuer's Prospectus Supplement on Form 424B4, filed with the U.S. Securities and Exchange Commission on January 31, 2023 and (ii) 205,765 shares of Class A Common Stock that are issuable upon exercise of the pre-funded warrants (the "<u>Warrants</u>") that are held by the Reporting Persons, subject to a blocker (the '<u>Blocker</u>").

As of January 31, 2023, the Reporting Persons hold (i) 1,085,765 shares of Common Stock and (ii) an additional 3,914,235 shares of Common Stock issuable upon full exercise of the Warrants held by the Reporting Persons. Due to the Blocker, the Reporting Persons are prohibited from exercising the Warrants into shares of Class A Common Stock if, as a result of such exercise, the holder, together with its affiliates and any persons acting as a group together with such holder or any of such affiliates, would beneficially own more than 9.99% of the total number of shares of Class A Common Stock then issued and outstanding immediately after giving effect to the exercise. As a result of the Blocker, beneficial ownership of the Reporting Persons is capped at 9.99% of the outstanding Class A Common Stock of the Issuer.

As of January 31, 2023, Ionic is the beneficial owner of 1,085,765 shares of Class A Common Stock (the <u>Shares</u>"). Ionic has the power to dispose of and the power to vote the Shares beneficially owned by it, which power may be exercised by its managers, Mr. O'Neil and Mr. Coulston. Mr. O'Neil and Mr. Coulston, as managers of Ionic, have shared power to vote and/or dispose of the Shares beneficially owned by Ionic. Neither Mr. O'Neil nor Mr. Coulston directly owns any Class A Common Stock of the Issuer. By reason of the provisions of Rule 13d-3 of the Act, each of Mr. O'Neil and Mr. Coulston may be deemed to beneficially own the Shares beneficially owned by Ionic.
